If provided, your TFN will be tied to your First Super account, and will be used only for lawful purposes as outlined in the First Super Product Disclosure Statement and this form. This use includes helping us to search ATO records with your consent for any super amounts in your name held by the ATO or by another super fund.

You are not obliged to provide your TFN to First Super. However, giving us your TFN has the following advantages:

- we will be able to search for extra super amounts
- we will be able to transfer other super amounts found into your First Super account
- your employer and salary-sacrificed contributions will not be taxed at your highest marginal tax rate
- First Super will be able to accept personal after tax contributions.
