## Nonmaterial event notice Product Disclosure Statement

This notice identifies typographical errors contained in the More about First Super document dated 29 September 2022 which forms part of the Product Disclosure Statement dated 29 September 2022. A new version of the More about First Super document dated 27 October 2022 has been published on our website.

On 29 September 2022 we updated our Product Disclosure Statement including the information about the fees and costs of our product contained in the More about First Super document.

Unfortunately, the 'Cost of product information’ shown in the table on page 10 of More About First Super was incorrect. Three of the investment options incorrectly disclosed a slightly higher cost of product, while one investment option incorrectly disclosed a slightly lower cost of product.

The following table shows the incorrect information (as published on 29 September 2022) and the correct information (as published on 27 October 2022).
